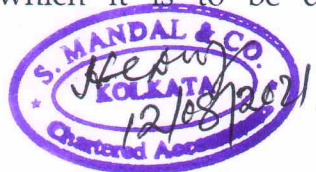

1. We have reviewed the accompanying statement of unaudited quarterly financial results of HOTAHOTI WOOD PRODUCTS LTD (the "company") for the quarter ended 30th June , 2021 being submitted by the company pursuant to the requirement of Regulation 33 of the SEBI (Listing Obligations an Disclosure Requirements) Regulations, 2015 , as amended . Notes to financial Results:

- The above results for the quarter ended 30th June, 2021 which have been subjected to review by Statutory Auditors of the Company were reviewed and recommended by the Audit Committee and subsequently approved by the Board of Directors at its meeting held on 12th Day of August, 2021, in terms of Regulation 33 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 (as amended).
- Due to COVID-19 pandemic and the consequent lock down announced by the Government of India, the operations of the company were suspended since the third week of March, 2020 to October, 2020 (Previous year). During the current period the company were operational only for the month of April, 2021 with restriction of 50% of the normal capacity and again required to suspend operation consequent to lock down announced by respective state governments. The company has assessed the potential impact of COVID-19 on the recoverable values of its financial and non-financial assets and impact on revenues and costs. The company considered internal and external sources of information and has performed sensitivity analysis on the assumptions used and based on current estimates, expects to recover the carrying amount of these assets. The impact of COVID-19 may be different from that estimated as at the date of approval of these financial results. The company has also evaluated the possible impact of this pandemic on the business operations and the financial position of the company and based on its assessment of the current indicators of the future economic conditions, believes that the financial results for the period ended 30th June, 2021 may not have any material adverse impact on the net worth of the company. The management will continue to monitor any material changes to its COVID-19 impact assessment, resulting from the future economic conditions and future uncertainty, if any.
- The figures for the quarter ended 31st March, 2021 are the balancing figures between audited figures in respect of full financial year ended 31st March, 2021 and the unaudited published year to date figures up to the 31st Dec, 2020 which are subject to limited review.
- The business of the Company falls within a single primary segment viz., financing, and hence, the disclosure requirement of Ind AS 108 - 'Operating Segments' is not applicable. Figures pertaining to the previous period have been rearranged / regrouped, wherever considered necessary, to make them comparable with those of the current period.
